OUTCOMES THAT DON'T PASS THE "CHECK"

Missing the "what changes for participants as a result of this" component

"Participants, by engaging with their peers,

increase their understanding of the pros and cons

of blossom thinning in orchards."

OUTCOMES THAT DON'T PASS THE "CHECK"

Discuss in "project notes", "project summary", "project reflections" sections of RVS.

Missing the participant focus

"The Hub will strengthen relationships with dairy farm owners in the state, leading to future collaborations on risk management education."

COMMON MISTAKES Combining multiple outcomes:

"Producers will understand and implement IPM strategies for pest identification and monitoring."

"Participants increase their understanding of IPM strategies for pest identification and monitoring."

"Participants will <mark>implement at least one new</mark> IPM strategy."

"At least 25 farmworkers will report improved English language communication skills and improved overall wellbeing as a result of participation in on-farm English classes."

COMMON MISTAKES Not specific enough:

"Beginning farmers gain practical skills through workshops and training."

"Beginning farmers learn practical skills in safely operating heavy machinery through

workshops and training."

- Mistaking activities and outputs for outcomes:
- "Producers continue to work regularly with an instructor on data gathering, financial benchmarking, and cover crop risk management education."

Producers work regularly with their instructors on financial benchmarking in order to improve their financial benchmarking practices**.**

and financial analyses"- <mark>UNDERSTAND producer action.</mark>

"Participants will use their skills to <mark>improve their recordkeeping practices.</mark>"– IMPLEMENT producer action



- How verified: Attendance at workshops or 1:1 meetings

SUMMARY OF COMMON MISTAKES

- **Combining multiple outcomes**
- Using website visits/ analytics as outcomes
- **Outcomes not specific enough**
- Mistaking activities and outputs for outcomes
- Not choosing the right producer action
- Using website analytics as a verification method
- Using attendance as a verification method
